## Government Net Revenue Collection: The First Eleven Months of Fiscal Year 2016

Mr. Krisada Chinavicharana, Director-General of the Fiscal Policy Office and Ministry of Finance's Spokesman, announced that the government net revenue collection during the first eleven months of fiscal year 2016 (October 2015 – August 2016) totaled 2,181,687 million baht, 63,779 million baht or 3.0% above the target, and 9.1% higher than the same period last year, mainly due to the remittance of 4G licensing that amounted to 56,273 million baht. Moreover, the remittance from State Owned Enterprises was above the target by 10,193 million baht or 9.2%. Petroleum and petroleum product tax, excise tax on automobile and personal income tax exceeded the targets by 8,936 7,548 and 6,369 million baht, or 5.9% 8.8% and 2.2% respectively.

Mr. Krisada concluded, "Given the government net revenue collection during the first eleven months of fiscal year 2016 was higher than the target, I am confident that the government will achieve the revenue target this fiscal year. This strong fiscal position will support future economic expansion."
